Course Information: Novice will be a outrun, lift fetch, wear, pen. Ranch will be outrun, lift, fetch, 1 leg of drive, pen. Pro-Novice will be outrun, lift, fetch, full drive, pen. Novice class will have stock set to a feed pan (no spotter.) Ranch & Pro-Novice will have a light hold on the sheep with dog/handler team in the field.

Fees: All classes are \$37 each run. TWO compete runs offered for each dog. One in the morning and one after lunch. We will have a pot-luck lunch so bring a dish to share.

Class Information: <u>Novice Class:</u> No handlers who have competed in Open. No dogs that have competed in a driving class. <u>Ranch Class:</u> No Open handlers or dogs that have competed in cross-drive class. (Class restrictions refer to USBCHA style trials.) <u>*NEW* Pro-Novice Class:</u> Regular rules from USBCHA style trials apply. If you have any question on which class is appropriate for you to enter, please contact trial host. Priority for Pro-Novice entries given to Novice/Ranch handlers. Entries will be limited based on availability of sheep.

Awards for 1st through 3rd places for each run/class. Placements will be sent in to WWSDA for inclusion in year end points.
